The applicant must take due care while filling up the Online Application Form. The information provided by the applicant in his/her Online Application Form shall not be changed or altered in any case and the University will not entertain such request under any circumstance. The University shall not be liable for any mistake made by the applicant.

There is no provision of revaluation/scrutiny.

The information provided and the data supplied by the applicant through Online Registration Application Form shall be preserved in the University for a period of only 90 days from the date of the declaration of the result of Entrance/Admission Test. The records will be disposed off after the said period and no enquiry shall be entertained in this regard by the University after the expiry of the said period. The University shall use this data for various purposes; hence, in no case shall any change be allowed at a later stage. **Eligibility Information:**

1. The candidate must have obtained Law Graduate Degree from any University recognized by U.G.C. and the candidate should have obtained at least 50% marks in the aggregate in the said class candidates who have appeared in Law Graduate (Final Year) are also eligible to apply and appear in the LL.M. Admission Test-2016. However such a candidate will have to produce his or her final year marksheet as a proof of passing LL.B. (Final Year) examination on or before the date of admission, failing which their claim to admission shall stand forfeited.
2. For admission to LL.M., preference shall be given to fresh Law graduates (i.e. candidates who have passed the qualifying law graduate examination for the immediately preceding academic year) over Law graduates of earlier years. Accumulative discount at the rate of 5% of the Standardized Score shall be applied for every gap year in case of earlier Law graduates, subject to the maximum discount of 15%.
3. Prospectus/Forms/information brochure are available Online only on the website <https://www.digialm.com/EForms/html/form4394/index.html> OR Admission-2016 link of [www.allduniv.ac.in](http://www.allduniv.ac.in) for downloading and submission of form.
4. The Admission Test shall be conducted **on line** and shall have objective type/multiple choice questions only.
5. The Admission Test shall have **150 objective type/ multiple choice questions** and shall be of two hours duration.
6. **The question paper shall have two parts namely Part-A of 50 questions related to General Legal Awareness and Legal Aptitude; and Part-B of 100 questions related to the following subjects.**
  - (i) Constitutional Law of India, (ii) Jurisprudence, (iii) Law of Contract/Mercantile Law, (iv) Criminal Law, (v) Law of Torts. (vi) Hindu Law, (vii) Muslim Law, (viii) Public International Law and Human Rights, (ix) Labour Law, (x) Property Law.
7. Each objective type/ multiple choice questions shall carry **three marks** only.
8. For each right answer the candidate shall be awarded **three marks** whereas for each wrong answer **1 mark** shall be deducted.
9. The Admission shall be done in accordance with the uniform policy for P. G. Admissions-2016 prevailing at the time of the admission.
10. The amount paid by the candidate to the University as the Registration/Test-fee will not be refunded or carried over under any circumstance.
11. The candidate shall fill all the required entries (including his signature) on the form otherwise the form shall be considered as incomplete and be liable to the rejected even after being received and processed by the University of Allahabad.
12. The candidate shall be responsible for the veracity of all the entries in the Registration Form.
13. Once a Form has duly been submitted to the University, the candidate shall not be entitled or permitted to make any addition, deletion or alteration in respect of any

entry therein and the Form shall not be permitted to be transferred / used for any course other than LL.M.

14. Carrying Mobile Phones or any other material, except Admit-card and black/blue ballpoint pen, in the Examination hall shall be treated as unfair means.
  15. The ADMIT-CARDS can be downloaded online w.e.f. **21/05/2016**.
  16. **NCC Weightage:** A weightage of 5 % shall be added to the score obtained by the candidate in the Admission Test / Entrance Test, who holds the 'C' certificate of the National Cadet Corps (NCC).
  17. **Physically Challenged Quota :** A candidate who has a certified disability of not less than 40 % in any limb or in orthopedic structure which, in the opinion of the Medical Board (constituted by the University of Allahabad), amounts to an overall physical handicap of not more than 70 % or is a certified blind, may be admitted to the concerned course / subject, irrespective of his position in the order of merit of the total aggregate score, on the recommendation of the Medical Board, subject to the condition that number of such candidates shall not exceed 3 % (1% Hearing impaired, 1% visually impaired and 1% Orthopedic disability and Cerebral palsy) of the total seats in the respective course / subject. The privilege shall not be given except claimed by the candidate at the time of application. At the time of admission the candidate shall be required to produce a certificate issued by the Chief Medical Officer of the appropriate District or by the Viklang Kendra, Allahabad, which testifies to his disability and bears an attested photograph indicating his / her disability clearly.
- 17 a. All candidates entitled to be admitted under the above quota to a course shall be adjusted against their respective social category.
  - 17 b. Seats under Physically Handicapped quota shall be filled in order of preference given below ;
    - (I) Visually impaired
    - (II) Hearing impaired
    - (III) Orthopedic disability
  - 17 c. Seats of each category given in 17.b.(I), (II) & (III) shall be filled on the basis of order of merit of the candidates in the Admission Test."

**IMPORTANT INSTRUCTIONS**

1. At the time of the admission the candidates must possess a pass degree of the undergraduate course.
2. After admission the candidate must deposit his Migration Certificate / Transfer Certificate at the counter after filling up the prescribed form.
3. A candidate must get himself enrolled in the university and department after admission to course so that his name may be mentioned in the class register.
4. After admission the candidates must get an I-card prepared immediately.
5. After passing the II<sup>nd</sup> Semester the student shall deposit the requisite fee within 15 days of the declaration of result in the University Law fee counter.
6. After deposition the fee he must get his I-card prepared for the next session in Proctor Office.
7. He shall also be required to report in the Department and get his name registered in the class register along with a copy of fee receipt and mark sheet; otherwise his name shall not be forwarded to Controller of Examinations.
8. Student shall be required to attend the classes regularly as per the classes allotted to them in the time table.
9. No student shall be allowed to appear in the exam if they fail to attend 75% of the classes as per Bar Council Rules.

### **DEPARTMENT OF LAW**

### **UNIVERSITY OF ALLAHABAD**

In order to ensure that the curriculum of LL.M. Course and the evaluation and examination systems thereof are in line with the latest recognized standards on the national and global levels, the University of Allahabad has drastically changed the nature of syllabus and the systems of examination and evaluation w.e.f. Academic Session 2016-17. Having been approved by all the statutory bodies of the University the new LL.M. Course shall be of Two Years duration divided in Four Semesters; and in the evaluation the Choice Based Credit System (CBCS) shall be applied in the larger interest of the students pursuing this course. The information given here under forms parts of the Ordinances for LL.M. Degree Course of Study and Examination

**1. THE DEGREE OF MASTER OF LAWS** The University of Allahabad may confer the Degree of Master of Laws on such candidates who, being eligible for admission to the LL.M. Degree Course, have received regular instruction in the prescribed courses of study, passed successfully relevant examinations and being otherwise suitable by virtue of their character, have fulfilled such other conditions as may be laid down from time to time by the appropriate authorities.

**2. THE CURRICULUM AND DURATION OF STUDIES**

**A.** (i) The Curriculum of study for the LL.M. Degree shall comprise of the courses set out in **Schedule A.**

(ii) The Departmental Committee shall prescribe the detailed content of various courses of study before the beginning of each session. The Departmental Committee shall be free to make changes in the optional papers for each session, subject to the availability of teaching facility/ Faculty.

**B.** The Curriculum of study for the LL.M. Degree shall be spread over Four Semesters.

**3. REQUIREMENT FOR ADMISSION**

**A. Registration:**

(i) Candidates for LL.M. Degree shall first be admitted to the First Semester upon the reopening of the University after summer vacation every year through an entrance test as per existing Admission Rules.

(ii) After admission he shall get himself registered in the Department of Law.

A candidate, who fails to prosecute a regular course of study during any of the Second, Third and Fourth Semesters may get himself registered in any subsequent Year to the Semester concerned, but within such time as enables him to complete the study of all Semesters comprising LL.M. Degree Course within a maximum period of four years from the date of his registration for the First Semester.

**B. Minimum Qualification for Admission:**

(i) Admission to the LL.M. Degree Course of study shall be open to those candidates who have passed the Three Year LL.B. Degree Examination of this University or such Examination of any other University or Institution after Graduation under 10+2+3 pattern; or Five Year LL.B. Degree Course under 10+2+5 pattern as is

recognized by this University / Bar Council of India as equivalent for the purpose of LL.M. Degree Course and have secured not less than **50% marks** in aggregate in the LL.B. Examinations.

- (ii) The Faculty of Law shall be free to admit the students to LL.M. Degree Course as per the prevalent admission Regulations framed by the University.

**C. Conditions of Admission:**

- (i) No application for registration to the First Semester shall be entertained unless it is accompanied by:
- (a) A duly certified transcript of scholastic record of the candidate, commencing from the High School or equivalent Examinations,
  - (b) Original Transfer Certificate of a candidate who has been a regular student in any Institution at any time prior to making application for registration in the Department of Law; and also a candidate, who was earlier enrolled and his enrollment has been cancelled.

Provided that if a candidate is unable to produce any of the documents other than the marks-sheet of the LL.B. Examination, at the time of seeking admission in the Department of Law before admission committee, he shall undertake to submit them within one month or within such further period as the University authorities may prescribe; and the admission, if any, of such candidate shall, until the submission of the aforesaid documents, be deemed to be provisional.

- (ii) Candidate shall give also a written undertaking to the effect that:
- (a) He shall exclusively devote his time to the study of courses prescribed for LL.M. Degree and in particular he shall not offer any other course leading to a degree of any description whatsoever, nor shall he undertake any remunerative work,
  - (b) He shall not undergo practical training in Law for the purpose of being enrolled as an Advocate during his studies to the Degree of Master of Laws; and
  - (c) He shall abide by the provisions of the Allahabad University Act, Statutes, Ordinances, Regulation and Rules that are framed or may be framed there under and the orders of the Officers and Authorities of the University and the Faculty of Law from time to time.

**4. FEES**

The students pursuing the LL.M. Degree Course of Study shall have to pay fee as may be prescribed by the University from time to time.

**5. REGULAR COURSE OF STUDY**

**A. Course of Study:**

A candidate for the Degree of Master of Laws shall be required to:

- (i) Study **Two Compulsory papers** in each of the four semesters.

- (ii) Study **One Optional Group** in the First Semester, Second Semester and Third Semester from. Each Optional Group shall comprise of **three papers** enumerated in Schedule A.
- (iii) Write a **Dissertation in Fourth Semester** on a subject (topic) in consultation with the Supervisor nominated by Head of the Department of Law.

**B. Prosecution of Regular Course of Study:**

Every student is expected to have full attendance, i.e., 100% and for being eligible to appear in the end semester examination, a student shall be required to put in a minimum of 75% of attendance in lecture class in each paper as prescribed by the University and UGC, New Delhi.

**6. EXAMINATION**

**A. General:**

- (i) There shall be an end semester examination at the end of the First, Second, Third and Fourth Semester and the candidate enrolled for the Degree of Master of Laws shall be required to pass in all the prescribed papers / semesters within a maximum period of **four years** from the **session** of his being admitted to the First Semester.
- (ii) (a) A candidate shall be examined in **seventeen written papers**, each paper carrying one hundred marks and covering prescribed courses of study.  
 (b) Examination shall be conducted by means of written papers, each carrying **60 marks** and of three hours duration which shall be evaluated by the examinees approved by the **Board of Studies**.  
 (c) In each paper **40 marks shall** be reserved for award on the basis of performance in the class room for an internal assessment which may comprise of assignment in seminar, project work and or presentation or class test as may be decided by the Departmental Committee in beginning of each semesters.  
 (d) Dissertation shall carry **200 marks** out of which 100 marks shall be reserved for presentation before the Board and the written works submitted shall be evaluated **out of 100 marks**.  
 (e) The viva-voce Examination shall carry 100 marks and shall be held soon after the Fourth Semester Examination covering **all the areas of the papers studied by the student in all the four semesters**.  
 (f) The Viva-Voce shall be conducted by a Board of Examiners comprising of Three members, out of which Two shall be External Examiners and One shall be Internal Examiner appointed by **Board of Studies**.

**(B) Dissertation:**

- (a) Candidate shall be required to submit the Dissertation at least before 30<sup>th</sup> April of **each session** and in any case prior to the commencement of Fourth Semester Examination, with the prior permission of HOD Law.
- (b) The candidate shall be required to secure at least 40% marks in the Dissertation to pass the Examination. However, the candidate shall also be required to **secure 40%** in each component of dissertation that is written work and presentation separately.

- (c) The candidate who has failed to secure **less than 40% marks** Dissertation but have **secured pass marks i.e. 40%** in all other papers and 50% in aggregate may with the approval of the Departmental Committee opt to write a Dissertation on another topic and submit it in the next session along with the students of that session as an **ex-student**. However, he shall retain his marks in other papers.
- (d) The written work component of the Dissertation shall be examined by an external examiner who shall award the marks out of **Maximum marks of 100**.
- (e) Presentation of the Dissertation shall be examined by a Board of two examiners at least one of them shall necessarily be the supervisor and the other shall be HOD Law or his nominee.
- (f) The evaluation or presentation by the two examiners shall be done also **out of 100 marks**.
